

Dear Shareholders,

we have compiled answers to selected questions for you regarding the Annual General Meeting of MLP SE.

**1. Will the Annual General Meeting of MLP SE in 2026 be held as an in-person event and when and where will it take place?**

The Annual General Meeting of MLP SE will be held as an in-person event in 2026. It will take place on June 25, 2026 at the Palatin Kongress- und Kulturzentrum, Ringstraße 17–19, 69168 Wiesloch. Access to the Annual General Meeting is via the main entrance to the event premises. Admission is scheduled from 9:00 a.m. (CEST), and the Annual General Meeting will begin at 10:00 a.m. (CEST).

**2. Why did MLP SE decide to hold the Annual General Meeting as an in-person event in 2026?**

The Executive Board of MLP SE had already expressed its intention at the Annual General Meeting 2025 to hold the Annual General Meeting as an in-person event in 2026. This decision is based in particular on the interest expressed by many shareholders in engaging in personal dialogue with the Executive Board and the Supervisory Board, as well as with other shareholders. In addition, the Executive Board considers an in-person event to be an appropriate complement to the formats used in recent years. Against this background, MLP SE has decided to hold the Annual General Meeting in 2026 as an in-person event.

**3. What requirements apply for admission to the Annual General Meeting?**

The requirements set out in the Invitation to the Annual General Meeting shall be authoritative for participation in the Annual General Meeting. Shareholders who have duly registered for the Annual General Meeting in due time and form and have provided proof of their entitlement are entitled to participate and are requested to keep the admission ticket received for this purpose ready at the entrance.

**4. How can shareholders reach the venue by public transport or by car?**

Information on how to travel to the venue by public transport or by car can be found in the separately provided document containing organisational information for shareholders.

**5. Is the venue accessible without barriers?**

The venue is accessible without steps and provides barrier-free sanitary facilities. Please follow the corresponding signage on site.

**6. Are security and safety measures in place for admission to the Annual General Meeting?**

For reasons of security and order, appropriate security and safety measures may be implemented upon admission to the Annual General Meeting and during the event. In the interest of ensuring an orderly conduct of the Annual General Meeting, instructions issued by the security and order staff, as well as by assistants deployed by the Company and external service providers commissioned by it, must be followed.

**7. Is a cloakroom available at the venue?**

A cloakroom is available at the venue. The use of the cloakroom is at the user's own risk. There is no entitlement to use the cloakroom, nor is there any liability for items deposited.

**8. Will catering be provided for shareholders at the Annual General Meeting?**

Catering will be provided for shareholders as part of the Annual General Meeting. The catering includes a selection of food with vegan and non-vegan options as well as beverages. There is no entitlement to catering or to a specific offering.

**9. How can shareholders exercise their rights at the Annual General Meeting?**

**10. Is it possible to follow the Annual General Meeting 2026 via livestream?**

All shareholders of the Company as well as the interested public may follow the Annual General Meeting on June 25, 2026 from approximately 10:00 a.m. (CEST) until the end of the explanations on agenda item 1, including the speech by the Chief Executive Officer, live on the Internet via the Company's website at <http://www.mlp-agm.com>. No further audio and visual transmission of the Annual General Meeting is provided.
