# Contract of Dr. Uwe Schroeder-Wildberg extended by further five years

Wiesloch, 25th January 2017 – The Supervisory Board of MLP AG extended the current contract of Chief Executive Officer Dr. Uwe Schroeder-Wildberg, which expires on 31st December 2017, by five years to the end of 2022. The 51-year old CEO has been at the helm of MLP since 2004.

At the start of 2003, Uwe Schroeder-Wildberg moved to MLP to become Chief Financial Officer and a member of the Executive Board at MLP; since 2004 he has been Chief Executive Officer.
